His trial takes place on 25.10.2007 in the Criminal Court of Duhok, North of Iraq.

Mr. Ahmad was first detained in the Kurdish Security Force prison for one month and was, then, transferred to Al-Zarga prison, Duhok, North Iraq. He is still in prison now.

- 3. Forces holding the detainee under custody: **Kurdish Security Forces**
- 4. Places of detention (indicate any transfer and present place of detention):

Al-Zarga Prison – Duhok, Iraq

- 5. Authorities that ordered the detention: Unknown Kurdish Authorities
- 6. Reasons for the detention imputed by the authorities:

No official documents were given to the prisoner or to his family members.

The following information was received from a first degree relative of Mr. Ahmad: Mr. Ahmad is accused of intelligence activities for Turkey and for the killing of a Kurdish man. This has been said to the family members of Mr. Ahmad by the prosecutor.

The lawyer in charge of the trial has also denied receiving any official documents about the charges indicted on Mr. Ahmad from the authorities.

The accusation for the killing of the Kurdish man relates to an incident during the pillage of the government offices in Al- Rashidiya following the occupation of Iraq in 2003. It is well known that almost all the governmental offices in Iraqi were exposed to robbing and pillage after the occupation of Iraq at 09 April 2003. The buildings were evacuated and burned and the autos were stolen. On 11 April 2003, the governmental offices in al-Rashidiya city were attacked by robbers from outside the city causing resistance from the city's inhabitants. During the fighting, two Kurdish attackers and two city's inhabitants (One Turkmen and one Arab) were killed. Mr. Ahmad is accused of killing one of the Kurdish attackers. The family claims that Mr. Ahmad was not in the city on the day of the event.

On 09 July 2007, Mr. Lokman was taking part in the Turkmen delegation attending the conference organized by the Turkmen Scientist Professor Ihsan Doğramacı in Ankara, Turkey. The delegation included representatives from different Turkmen regions in Iraq such as Kerkuk, Mosul and Erbil. After completing the customs procedures, the delegation started to move to cross to Turkey. At that moment, Mr. Ahmad was held back.

Mr. Ahmad was arrested by a Kurdish staff just before crossing the border and was sent to the Kurdish security office (Asayish) in Duhok without any official reason given to him.
